1. **Board Members and Leadership Appointments:**
 - President: Dr. Manoj Shah
 - Vice President: Mr. Subhash Bhatt
 - Secretary: Mr. Pravinchandra Patel
 - Treasurer: Mr. Rajesh Shah
 - Trustees: Mr. Neeraj Kashalkar, Mr. Pratap Champsi, Mr. Ikshwaku Oza, Mr. Nitin Modi, Mr. Vijay Telkikar, Prof. Swati Desai, and Mr. Bharat Solanki.
 - All appointments are for a term of three years (2025 to 2027).
2. **Non-Profit Status Process:**
 - Begin the process to obtain 501(c)(3) Non-Profit status using LegalZoom's "Standard" plan (\$239 + state filing fees) and 1023.org (\$399).
 - Secretary Pravinchandra Patel is authorized to obtain an EIN number, verify documents, and complete the legal process.
 - The Secretary is also authorized to open a bank account with JPMorgan Chase Bank.
3. **Website and Email Setup:**
 - Mr. Ankur Patel is appointed to set up the organization's email and website, with assistance from Mr. Ronak Patel of Ideas Plus Support (India).
4. **Fundraising Plan:**
 - Board members will solicit donor commitments but will not accept funds until 501(c)(3) status is approved.
 - Donations will be invited annually, with suggested amounts starting at \$501 (less or more as per donor's wish).
 - Beneficiary charities will be selected based on alignment with the foundation's principles and government regulations.
